Waith Discusses The Crystal Kingdom, Abuses That Have Occurred, And The Community

It is a most interesting gathering of energies in this session that we have and we welcome you all, and as is our belief at times, it becomes necessary to reinforce certain information that we present that perhaps becomes forgotten in the excitement of the moment. And this particular information that we refer to is regarding The Mineral Kingdom. There is tremendous abuse of The Mineral Kingdom, far more so than any of the other kingdoms including The Animal Kingdom. The Animal Kingdom is given much more care and attention than The Mineral Kingdom, and energy that enters into The Mineral Kingdom understands this before entering into this kingdom and knows that there are lessons very specific to that kingdom that will be learned, as well as lessons that will be taught.

There is tremendous resistance on the earth plane to the notion that The Mineral Kingdom indeed has life, for you would say a rock is a rock and has no energy and has no life, therefore. And, of course, this is not correct. However, this is the illusion that is set up on the earth plane, and thus it is that The Mineral Kingdom members know this, that there will be a tremendous abuse. And abuse comes in many forms for The Mineral Kingdom. It comes in attitude toward it, the kingdom itself. It comes in an attitude from those in other kingdoms, thinking that they are better than The Mineral Kingdom. For energy is energy, my loved ones, regardless of what form it happens to be in at any given time, and all energy is connected to The Universal Consciousness. You are just as connected to the energy that is currently encased in a rock as you are to the energy that is encased in the human form. You are just as connected. We are all connected at some point.

Now, the abuse, then, becomes very, very strong for some entities who would simply use the encasements of energy in The Mineral Kingdom for their pleasures, for their own seeking of ornaments and adornment. The abuses also come in the form of misunderstanding the tremendous power that those energies in The Mineral Kingdom possess. The Mineral Kingdom is designed to be what you might call a conduit for other kingdoms. This means that they are of service to help in healing, to help in protection, to help in giving knowledge to store information that can be accessed at a future time in another illusion, millions and millions of earth plane years hence.

And when entities in the human encasement acquire certain levels of ability and power, they know that they can program a crystal, shall we say, and this is an appropriate, for the crystal, those in The Mineral Kingdom, are designed themselves as energies to be utilized in that way, to be told what they will provide, and when done in a spiritual context by the human encasement and the energy in the encasement, then there is a positive result. When this is abused by the energy in The Human Kingdom, then the crystal can be programmed to do harm or to provide some type of ill situation, some type of negativity. And it appears that at times even those entities who have a sensitivity to crystals, and others in The Mineral Kingdom, forget the vulnerability that not only the

mineral itself has, but also the impact that that has upon the earth plane's electromagnetic field as well as the energy in the human encasement that the programming may be directed toward or groups of entities that certain types of programming can be directed toward.

You must remain vigilant if you are to be working with The Mineral Kingdom, to Be of Service, that your workings with The Mineral Kingdom are not in a way that you would take advantage, or take for granted, the abilities of the mineral or its selflessness in Being of Service. There are some energies in The Mineral Kingdom that have advanced to a particular state in their own field of energy that they can indeed resist what might be referred to as harmful programming and they can, in fact, protect not only their own energy from this programming, but they can protect others in The Mineral Kingdom from that type of programming. However, just as many in the human encasement are unable to protect themselves against forces that would attack, so too is this the case in The Mineral Kingdom. You have a very powerful tool at your beck and call, shall we say, when you are able to utilize The Mineral Kingdom.

Now, there have been recent abuses by a number of entities in which Mushiba and Abalma find themselves surrounded. And there has been, of course, no impact made upon either one of them, for they are able to protect themselves against that type of abuse. However, the attempts have been there, and there have been attempts at infiltration into The Mineral Kingdom that surround the Community of Terra Lux. And this has been taken care of by Mushiba at spirit level, but understand that at the earth plane level there are issues that need to be addressed very, very closely.

The crystals, and others in The Mineral Kingdom, are here within the Community of Terra Lux to be of a particular service. And when they are, as we would say, tampered with from outside sources and forces, it presents a most precarious situation for all who would be a part of the community, as well as all who would come into the vibration of the community, who would come to be a part of the community or to seek solace from the community. The vibration of The Mineral Kingdom is strong for it reflects the strength and the beauty that exists with the Community of Terra Lux, and it is what makes this vibrational field of energy so very strong and beautiful.

However, this gathering of energies in the Community of Terra Lux is like so many other gatherings throughout the Planet Earth who have grouped in an effort to prepare for The Shift, at a very minimum, but who, without thinking about an illusion change about to present itself, have simply grouped in an effort to gain spiritual growth and to support and love and to Be of Service ~ and by utilizing the energy from The Mineral Kingdom, much growth and advancement can be achieved. As soon as the abuses begin, any grouping of entities, not just Terra Lux, will find themselves in danger of being susceptible to attacks and losing sight of the mission of the spreading of love and the sending of Light so that the actual issue of darkness becomes nonexistent.

There have been many of the crystals that a significant number of those of you gathered in now, they have been contaminated. It has been taken care of, shall we say, for the beacon crystals that were given special energy in the last cleansing of The Mineral Kingdom that occurred has enabled these particular beacons to send out a cleansing to those of their own kingdom who have cried out for assistance.

You all must be very, very careful. Those energies in The Mineral Kingdom are not playthings for your amusement, and while we know that many who hear our words in this gathering understand that, and this information is not, shall we say, applicable to many of you for you have not abused, there will be many who will read this information in the future and it will serve as a reminder, and it needs to be a rather continual reminder that The Mineral Kingdom is not to be toyed with. It is not to be tossed around and is to be viewed with an attitude that they are a part of you.

And this is a difficult concept for many on the earth plane in human form to accept, for a part of the human encasement is a certain arrogance that there is no other higher energy than the human encasement and that the other kingdoms are, therefore, lower. There are no higher or lower kingdoms, my loved ones. There are simply different encasements for fields of energy to learn certain lessons and to teach certain lessons. Do not delude yourselves into thinking that you are better than an energy that is in another kingdom. You are no better, nor are you any less. All are equal, and all must treat each other with respect and love, for when you fail to do so, you therefore fail to treat yourself with respect and love.

And as it relates to the Community of Terra Lux, there will be attempts at further infiltration into The Mineral Kingdom that surrounds the vibration of the community, and you must, therefore, be very, very careful for the short term approaching now. And if you are uncertain about a contact that you make who has minerals, then you must check with us if you are unable to find the answer through your meditations, and you may check with Mushiba for she will be able to give you a sense of the direction that you need to go in and all that relates to the Community of Terra Lux. You must as a community determine the welfare of your own entity, the community, for you are the community, and you determine those of The Mineral Kingdom that will become a part of the vibration.

Thus, it is important now to be cautious about crystals especially, for they have very strong programming abilities and others of The Mineral Kingdom that have particularly strong programming abilities. Be very cautious and protective of your Mineral Kingdom members that have found their way into your vibration.

There are currently in the vibration that surrounds now this gathering, new entrants from The Mineral Kingdom that have been programmed that has given ~ been given the appearance of being appropriate for the community but are not. They have been programmed. There are some members of The Mineral Kingdom that come now from a source that has a proved track record, shall we say, of abuse, and there is, once again,

the attempt to infiltrate. We know this, and we take care of this. However, we say to you that unless you are yourselves careful, then the next time that this infiltration is allowed to occur because of your own lackings in sensitivity, we will allow the infiltration to take its effect, to show you the true powers.

We were given permission from Amelius to stop the infiltration by neutralizing the programming that was in particular minerals. We will not be able to do this in the future if you do not pay heed to this caution, for most who are on their spiritual path surround themselves with crystals, and it is a very good opportunity for those who would want to abuse the crystals to, at a very minimum, program mischievous types of situations that could in effect short circuit your own energies.

It is not very often that we need to speak in such a strong manner, but this is a very important issue. And you need to understand that you are a community and that you must work together as a community and that you are now attempting to become strong and closely aligned with each other, and yet you continue to act in ways that are separate from each other without paying attention to the consequences of your particular behavior.

And understand that we are here to Be of Service to you to help you in understanding and working toward becoming cohesive, and that Mushiba is here to Be of Service in the same way, and when you bypass Mushiba, and when you bypass us to assist you in Being of Service, then you ignore very valuable sources of guidance. And the community itself, all of you who have the potential to be very strong and project tremendous love and Light, will crumble from within. Groupings of entities are, at very best, difficult to maintain harmony, for ego becomes an issue, and the abuse issue is an ego issue.

Now. We have concluded our reprimand. And Mushiba was not aware that we were going to do this, and she was planning that we would speak with you regarding another issue of this video. This will be done at the next session that we gather, for we want you, since the majority in attendance comprises the core community, or a significant part of it, we want you now to think about what we have presented to you, and also, that those energies who are currently with us in this session who are not a part of the core community, and those who would read the transcript of this session, will be aware of the vulnerability of any grouping of entities and that you must not all take yourselves so seriously. What you do as your mission is serious. But, you see, many of you are forgetting the mission, the spreading of love and Light and your spiritual growth, but rather, you are taking yourselves seriously. This must ~ must change. You must lighten up.

And we will continue to discuss this topic when we feel it is appropriate to remind you, for how many times have we said these statements? The Editorial Tribunal could probably keep busy for months extracting from the times we have given out this message of taking yourselves too seriously. Do not forget the mission. Put Self aside. It is difficult. It is most difficult to do this. It is very easy to hear the concept, to read the concept, to

even preach the concept, but to act the concept, that is the difficulty. There is no one any better than anyone else. No energy in existence is any better than any other energy. As we have indicated before, the only difference among energies is their point on the path back to The One. That is all. That is the only difference, and if you are further along in your path back to The One than another energy, it is your responsibility to assist those who would seek it, who are not as far along.

And those of The Mineral Kingdom provide themselves as tools to you for your own spiritual growth, as well as your guidance and assistance to those who would come to you. The Mineral Kingdom presents itself as total service. Take it as an example for your own behavior. Love and protect your crystals. Love and protect them. Do not take them for granted, and certainly, attempt not to place them into situations of vulnerability for which they may have no defense. If they are entrusted in your care it is your responsibility to be ever vigilant where the minerals are concerned.

We would take a few questions.

A Question About A Purse Including Crystals Going Through X-Ray Security At The Airport

My purse was searched at the airport and my crystals looked like something apparently dangerous in my purse on the x-ray machine, and this gentleman that searched my purse ~ there was obviously something going on when he picked them up. You are smiling, so I do not have to worry about anything.

No, indeed.

What was happening? He was pointing it at himself and I thought that was rather interesting.

They were communicating.

I felt something going on. He is still thinking about it, I am sure.

Oh, indeed. Yes. He is not quite certain as to what that was all about and does not want to think at such an earth plane level that he felt a message coming. It was a love vibration that was being sent.

I sensed that but I just wanted to confirm.

Indeed.

Trusting In Your Own Instincts, Learning And Growing, And Being Tested

We plan ourselves to trust our instincts, as far as how the crystals feel to us, and if they are appropriate for us, and that feels that they want to be with you, that you can Be of Service with each other ~ and the same as with meeting an entity. I am confused then if feeling your instincts that this person seems to have a feeling towards the crystals as you do, then maybe you are finding out later that your instincts were wrong.

Remember that the trusting in the instincts, as you call it, is in itself a lesson that you will be tested on periodically, for the tendency is to become complacent about what you think are instincts rather than truly going within through meditation. And there is the tendency, you see, to think that you do not need to meditate, and that, "Oh, I feel this particular way. This must be my instinct." And for many of you, this will be appropriate. It will indeed be the right answer, but understand that you will be tested.

You will be continually tested until your soul knows that you have learned the lesson and that ego is no longer a part of that which you think is appropriate, and it simply happens. You do not even think that, "Well, my instincts tell me this," and you even think about this situation that your instincts are in fact kicking into the situation. It simply happens. You simply know without it being an issue, you see. And thus, continue to go with that which you call your instincts, but be aware that periodically you will be tested for your own levels of complacency, and that powerful entities can indeed cloud over the energy field that surrounds you and can indeed make you believe that what you are feeling is correct as an instinct.

This entity ~ (Some words inaudible on tape) of the darkness?

You must understand that when you speak of the darkness, and we will again continue to say this until it is understood, that the darkness is relative to your own point on the path. The darkness is an attitude by an entity as it projects itself in relation to other entities. And while one entity may appear to be dark to you, that entity may be Light to another.

Waith, may I ask about the image that appeared on one of the crystals, of the mother and the child in the pyramid?

We have addressed that earlier in this session. It is not appropriate for the community. It has been diffused. It has been neutralized.

Will Those Who Abuse The Mineral Kingdom Eventually Know They Were Abusing?

Waith, those who abuse The Mineral Kingdom in their search for minerals, will they eventually be trained to know what they were doing? Will they eventually know that they were abusing?

Yes. It is the same situation as any lesson that needs to be learned. The abuses occur in order for the growth to come about and that all energies are abused, and abuse, in the path back, and it is in the abusing that an entity then realizes what needs to be achieved

for growth, and the abuses then begin to cease, and it is at that point that the entity who abused now assists that energy that was abused, and then will begin to guide and assist others who would abuse. So once the lesson has been learned by an entity, if that is in an area of abuse of The Mineral Kingdom, it will then become the responsibility of that entity to help others to lessen their abuse and to grow and strengthen so that that energy will then take its place in the scheme of growth, to cease the abuses.

You have said that normally we would not fall under attack by any entity that was any stronger than ourselves. How is it that such a strong entity could create deception for ~

There was not an attack upon you individually as an energy. There was an attack upon the illusion field that presented a different illusion, presented that which was not. This is an area in which powerful energies who choose to abuse are able to do so, where there is, shall we say, a playing about of the electromagnetic field of either you the entity individually or as a grouping.

Did the entity that made an attack on me last week have something to do with it?

No.

Waith, did this cause both physical and emotional problems with many of us?

Yes.

So, just to repeat your words in different words, I guess, it seems to be another time I myself felt some of those things and did not share it with anybody, that once again we need to be reminded to share.

That is correct, my love. That is correct.

A Personal Situation Where Someone Needed To Challenge An Entity In Their Meditation

Recently, I learned a valuable lesson with an entity who presented herself to me in meditation, and with your permission I would like to share it with the group.

Yes.

In one of my meditations, this very strong entity presented herself to me, telling me that she was to be a very significant help to us in the community. And she would be presenting herself through me, or through Waith, as another part of The Company, and she was going to serve a function to all of us. And she also gave me some information about personal issues. And after a time, some of the things that she told me started to bother me. At first, I thought this was wonderful. She was going to be this great help to us! And I started to question it, and I remembered what Waith had said about entities hiding their abilities to deceive, and I thought about it several times during meditation, and then I presented it to this entity and I said, "Look. You cannot deceive me for long,

if this is what you are trying to do, and if you are not, fine, I will value your information and I will pass it along to others. But if you are, you can leave now because we are not interested. And she has not visited me since. And several times over the past month I have wanted to ask about this particular person because I thought she was just wonderful. I felt so good about this person and thought perhaps I might even channel this person. And then it just did not sit right with me. I wanted to share it with all of you because now I know that. And I do not feel that she was necessarily dark or darker than myself. I just do not feel that she was appropriate for us. And I learned a lesson because I did not run out and say, "Look what I have." And I also learned that I did not need to ask Waith. I had to find it out for myself. And she has not visited me lately, so I do not think she was appropriate for us. Maybe some other time or some other place.

Remember that whenever you are visited, shall we say, in your meditations, or in altered states of consciousness, that you must challenge that entity. We have given you that information on how to challenge an entity, for if they are appropriate, indeed, my love, they will withstand the challenge. If they are not, they will not. And it does not take much to challenge. You see, many entities are ~ on the earth plane now, want so much to have a, what you might call, mystical experience. They want to be able to tell the others around them that they too have had communication with higher entities, entities in other forms. And these vulnerabilities are very, very open to those of the spirit world, you see. And your response, my love, was most appropriate.

Well, I learned something. And it just reminded me that we get so excited and caught up in something that we think it is really great, and then it turns out, well, maybe I ought to think about this just a little more before I jump into it.

And it is also appropriate to become excited about something, at all times, however, monitoring your own responses to any situation that occurs, without becoming obsessed with it, of course. But, when something appears to be very, very different from what you have been experiencing, then this in itself is a red flag for you, for growth occurs slowly and progresses over time ~ and advances are not like this, you see, with a snap of a finger, but rather, you grow into your own abilities at advancement.

And thus, to have something suddenly occur is a very rare phenomena, and is, therefore, a red flag for any of you, not that it is an inappropriate situation, for many will have a spontaneous type of situation, or what appears to be spontaneous, but for the most part you must be cautious about this. You must be cautious when something new is suddenly thrust upon you where you have not had any preparation for this. And be prepared to take on the new, but at the same time be cautious about it. Do not go into it unquestioningly. "My instincts tell me," you see. It could be a test for you.

Is it our own lack of respect in our handling and our dealing with crystals that causes them to become negatively programmed or infuse the negative ~

It can, yes, my love, in many situations, for if you begin to exhibit that type of attitude toward your own minerals, then they become susceptible to outside programming, for your own levels of caretaking have reduced themselves and leaves the energy field open that surrounds The Mineral Kingdom.

Is There Anything That We Can Do To Help Our Crystals?

We have on numerous, numerous times discussed appropriate care of The Mineral Kingdom. You must continue to have the bond that exists between those of The Mineral Kingdom that come into your care. It must be continually strengthened. Just as the energy bonds between those in The Human Kingdom are continually strengthened over time through respect and love of each other, and through interaction with each other, this is no different with The Mineral Kingdom. You must care for them. You must communicate with them. Many of them enjoy being touched, not just placed on the window sill and left to gather dust. It is a responsibility that you take on in the gathering of The Mineral Kingdom. Nurture the bond. Continually reestablish the bond.

Put them on pillows.

Yes. Have appropriate settings for them. Yes. The incubator crystal has a temporary cushion, shall we say, and the time will come when the incubator will have, shall we say, white stone underneath it. But this is a most appropriate positioning, you see. Such a vibrant crystal.

Now. We are ready to depart. And we would ask you to think very seriously now about who you are as a community, and what your purpose is, and what you want to project to the world around you, to all energy forms, whatever kingdom they happen to be in, for it will become appropriate that you have a very clear definition of who you are so that you can begin to truly project this to those who would seek your guidance, your assistance, your love. And if you know who you are, then you can easily project this to others, as well as to yourselves. This is your next task.

I beat Mushiba to it, for she was going to have you begin working on this, but it is appropriate that it be discussed at this time in the context of what we have just given you for information and that it become a part of the official readings file. You must know who you are and feel comfortable with who you are, and that that definition will change as you all as a community of individual entities change and grow and become stronger and more sure of yourselves as beautiful entities. Set aside the petty differences. Look for the similarities among yourselves. You are all beautiful energies, very beautiful. And continue to remember that just as beautiful as you are, so too are other entities around you beautiful. All is beauty.
